Arboricultural Electrical Safety (Greencard)

This course meets the requirements of current legislation and the New Brunswick Power Corporation tendering process.

This program prepares those working near power structures, such as transmission and distribution lines, to protect their safety and the health and safety of other workers.

Chainsaw

Participants will learn about proper chainsaw safety use and maintenance, with a classroom component where key areas of safety and operations are covered, followed by a practical session where individuals will use the skills learned in the theoretical sessions. The 1-day refresher has been developed for those who operate a chainsaw on a regular basis, have had prior training and have had previous experience using a chainsaw.

1-day Chainsaw Refresher

Fall Arrest Awareness

The goal of this course is to ensure students: know why it is important to have a fall protection procedure in place; what the key components are of a fall protection system; what the procedures are for the inspection, storage and maintenance of the fall protection equipment; the general method of using fall protection equipment; and applying the knowledge in the field. Proper use and inspection of harnesses and equipment will be shown to the participants.

Practical Loss Control Leadership (PLCL)

This 4-day North American recognized training program focuses on the prevention and control of occupational injury and illness, property damage, security breaches, pollution and product liability. We feel it is important that management and all employees understand and accept their role in making theirs a safe and healthy workplace. The material for this program consists of a text and 20 chapter exercises.

Traffic Control Person (Flaggers)/WATCHM Awareness

This course was developed by a Provincial Committee with representatives from the Department of Transportation, WorkSafeNB, Safety Services New Brunswick and Industry. The course objectives are 3-fold: to teach and train the traffic control person in the proper methods and techniques of stopping, slowing and directing traffic; to make participants aware of the potential results of poor traffic control procedures including death and injuries to the traveling public, fellow workers and themselves; and thirdly, to reduce the possibility of damage to equipment, vehicles and materials.

Covered are the TDG Act & Regulations as it pertains to land modes of transportation. The course is worker specific, made to emphasize all aspects of the act and regulations pertaining to the audience whether they are Shippers, Receivers, Couriers, Fork Lift Operators and Intermodal Transporters. Those working in proximity to dangerous goods and utilizing their Right to Know will benefit from this training.
